

RESOLUTION NO. 21-91

Resolution Of The City Council Of The City Of Emeryville Approving The Expenditure of An Amount Not To exceed \$15,000 From The Public Art Fund (Fund 243) For The City Hall Art Banner Project Consisting Of The Installation Of 15 Banners In Place Of Ten Existing Banners Located At City Hall

WHEREAS, Article 4 of Chapter 2 of Title 3 of the Emeryville Municipal Code establishes the Contributions for the Art in Public Places Program; and

WHEREAS, Section 3-2.404 of the Emeryville Municipal Code establishes the Emeryville Public Art Fund to implement the Art in Public Places Program (“AiPP”); and

WHEREAS, a goal of the AiPP is to locate public art in distinct neighborhoods throughout the City and thereby introduce the City’s public art to a larger audience; and

WHEREAS, as part of its 2021 project priorities, the Public Art Committee (“PAC”) identified several initiatives to celebrate the 30th Anniversary of the AiPP, and

WHEREAS, over the course of several meetings in June and July of 2021, an Ad Hoc Subcommittee of the PAC recommended scope, artists, layout, installation methods, and locations for removal of the ten existing *Then and Now* banners in City Hall and their replacement by 15 new banners featuring 30 artworks (the “Banner Project”); and

WHEREAS, on July 8, 2021, the PAC unanimously recommended that the City Council authorize the commission of the Banner Project; now therefore be it

RESOLVED, that the City Council of the City of Emeryville hereby approves the expenditure of up an amount not-to-exceed \$15,000 from the Public Art Fund for the installation of 15 banners in place of ten existing banners located at City Hall, consistent with the PAC’s recommendation of July 8, 2021.
