## RECOMMENDATION

As Chair of the MESA Board of Directors and Mayor, I recommend that the MESA Board and the City Council review and adopt the attached resolutions approving an extension of the term of the Agreement of Interim Appointment ("Agreement") between MESA and Andrea Visveshwara as Interim City Attorney for an additional three months, through January 31, 2022.

The MESA Resolution approves the Agreement and authorizes the Chair of the Board of Directors to execute the document with Andrea Visveshwara. The City Council Resolution approves and consents to the Agreement between MESA and Andrea Visveshwara. The proposed Agreement is attached as Exhibit A to both Resolutions.

## **BACKGROUND**

The MESA Board and City Council adopted Resolutions effective in April 2021 approving an Agreement of Interim Appointment with Ms. Visveshwara whereby she agreed to serve as the Interim City Attorney. The MESA Board and City Council are conducting a recruitment to permanently fill the position and pending the completion of that recruitment wish to extend the agreement with Ms. Visveshwara to continue her service as the Interim City Attorney. This item presents an extension of the term of the Agreement of Interim Appointment for approval by both bodies.
