City Clerk Sheri Hartz made an announcement about the upcoming annual recruitment for the City's community advisory bodies.

6. COUNCIL MEMBER SPECIAL ANNOUNCEMENTS / REPORTS ON MEETING ATTENDANCE

Mayor Bauters gave a special report about the recent incident of racism that occurred in Emeryville. Council Member Patz reported that he had attended the recent HUD Conference in Washington, DC. Council Member Donahue reported in his capacity as a member of the committee working to save the Alta Bates emergency services for the community, statig that Assemblymember Thurmond's Bill 2874 had passed through the Health Committee, and would require that hospitals that are planned to be closed would need written consent from the Attorney General. Council Member Martinez, who sits on the Board of Directors of East Bay Community Energy, stated that they had recently added a 100 percent renewable option to begin in late 2018. She also reported on Stop Waste, and spoke about China's policies against mixed recycling, which were affecting American exports of recycled materials.

Mayor Bauters continued with his announcements, reporting on his attendance of a bright night event put on by Rising Sun Energy, the J-Sei Showers of Flowers event, the recent Earth Day Shoreline clean-up event that was a big success, and the STEM career awareness day hosted by Wareham. He announced the upcoming Bike to Work day, which would be followed by a dedication ceremony at Peladeau Park, at the new extension of the Greenway. He also announced the art center listening session and some upcoming small business events, and thanked EUSD for the reconciliation of unpaid PBID funding and their account being brought out of arrears. He closed by reporting that the City of Emeryville had been selected to receive funding in the amount of 70%, with the remainder coming from the County toward creating rail safety crossings and quiet zones.

- 8. Peter, Bridgewater resident, opposed the waiver being approved, stating that weekends were the only time residents could relax due to existing weekday construction noise.
