Community and Economic Development Coordinator Amber Evans gave the staff presentation and responded to Council questions.

PUBLIC COMMENT

1. Jeff Krober, Townhouse Bar & Grill, spoke regarding the designation of his business location, stating that the Plan would cause problems for his business.

2. Michelle Bergtraum, owner of Emeryville small business, spoke on

behalf of small businesses in opposition of the proposed Plan.3. Ron Silberman spoke in opposition to the proposed Plan, stating that it was too complicated, and that there were inconsistencies in the information provided.

4. Josh Tillberg spoke in opposition to the Plan where metered parking was placed directly adjacent to permit parking.

5. Chris Jacinski encouraged strong consideration of privacy concerns related to use of license plate readers for parking management.

6. George Martin stated his concerns about 67th Street and the designations shown on the map related to long and mid-term parking, asking whether it could be permitted instead, and said he preferred kiosks to meters.

7. Sharon Wilchar spoke regarding residential parking along 45th Street, and pointed out that there were inaccuracies in the map designations.

8. Andre Carpiaux spoke regarding the need for more parking in the City.

9. Nasser Azimi stated that short term parking availability was critical to his business, and spoke in support of parking management.

Council discussion ensued, and direction was given on questions posed by staff. No action was taken at this meeting, and the item will come back for further discussion and possible action at a future meeting.
