City Manager Daniel opened the staff presentation and introduced consultants Emily Goodman, Senior Vice President, EMC Research, and TaShon Thomas from TBWB Strategies, who each presented portions of the report.

PUBLIC COMMENT

1. Navarre Oaks, with time yielded by Diana Keena, spoke in support of the measure, but stated that the number of positions to be funded should be stated explicitly. They gave suggestions about how the measure could be improved.
2. Andrea Malarkey, SEIU 1021, also spoke in support of the measure.
3. Bill Reuters spoke in support of the measure, stating it was necessary.

Council discussion ensued, with consensus being reached that the measure should be placed on the March ballot. Vice Mayor Patz stated he was interested in seeing the funding go toward a Crime Analyst and a Social Worker. Mayor Medina stated that the Code Enforcement Officer position was a high priority.

City Manager Daniel laid out to the Council what direction staff would need to proceed and meet the timeline. Council Member Bauters requested and received majority support to call a short special meeting on November 5, 2019 to consider forming an ad hoc committee of the Council to draft a direct argument in support of the proposed measure.

7. ADJOURNMENT

The meeting adjourned at 7:08 p.m.
