## 1. CALL TO ORDER

The meeting convened via Zoom webinar at 7:18 p.m. The Mayor read aloud a statement announcing that the meeting was being conducted remotely pursuant to the Brown Act waivers provided for under the Governor's Executive Order in response to the COVID-19 State of Emergency.

Mayor Patz announced that the Proclamation for Chief Tejada would be presented at an event to be held in her honor at the Police Station.

# 6. COUNCIL MEMBER SPECIAL ANNOUNCEMENTS / REPORTS ON MEETING ATTENDANCE

Mayor Patz called for a moment of silence to commemorate the death of George Floyd, and in recognition of Mr. Floyd's funeral having been held earlier in the day. The Mayor then read aloud a statement he had written wherein he thanked the Police Department and the Chief for their prioritization of people over property, and went on to thank the individual Council Members and staff for their work for human rights and their efforts on behalf of the Emeryville community. He called for action to end violence and racism, and announced an upcoming study session that would consider policing reform and seek public input on the qualities the public would like to see in a new Police Chief.

Following his comments, the Mayor reported that he and Council Member Donahue had attended the opening of the housing at the Robert Savage site, and stated that he was proud of the partnership between Oakland and Emeryville that made it possible. He concluded by announcing that scholarships had been awarded by the Alameda County Housing Commission as part of its Family Self Sufficiency Program.

Items #5 and #7 were combined and moved after Item #6. The City Clerk announced the upcoming appointments to City committees and commissions that would take place at the June 16, 2020 Special City Council meeting. The City Manager had no report.

## 13. DEPARTMENT HEAD REPORTS

**13.1.** <u>ID-2020-213</u> Planning Director's report on Planning Commission actions at the May 28, 2020 meeting:

- (a) Emeryville Center for the Arts. Second study session to review an adaptive reuse proposal that will involve renovation of an existing, 30,000 square foot vacant building at 4060 Hollis Street to accommodate an arts and cultural center.
- (b) <u>San Pablo Affordable Apartments</u>. Study session to review a proposal for redevelopment of a 0.39 acre site at 3600 San Pablo Avenue with a 7-story, 90-unit, 100% affordable housing project with a minimum of 3,600 square feet of ground floor commercial space for the Emeryville Citizens' Assistance Program (ECAP). The applicant proposes that the project be processed under SB 35, which mandates ministerial approval (i.e. staff level), and AB 1763, which specifies no density limit for projects within one-half mile of transit.

Council Member Bauters requested and received majority support to have a discussion on adopting a regulation on police use of "less-lethal" devices, to include the practices of our mutual aid partners when in Emeryville.
